Stay Informed and Engaged: Appoint or Confirm Your CLC!

The start of the 2016 legislative session is one month away! ACCG asks that all counties appoint or confirm their county legislative coordinator (CLC). The CLC plays an integral role in assisting with ACCG's advocacy efforts during the session. CLC's help keep county commissioners and county management updated on legislation of importance to counties and provide county-specific information to ACCG, as requested, in order to help legislators assess the impact of proposed bills.

County chairs are asked to officially designate a CLC by passing a resolution at a commission meeting.

Reminder: 2015 Immigration Report Due at the End of the Month

The deadline to submit the annual immigration report to the Department of Audits and Accounts (DOAA) is December 31, 2015. This year's report covers the reporting period of December 1, 2014 – November 30, 2015. DOAA opened the report collection system on November 1, 2015, and is currently accepting reports. No changes were made to the reporting system or county requirements during the 2015 legislative session. The DOAA sent a letter to each county in October containing an overview of the requirements and a list of resources that they have made available for assisting with the reporting process.

Counties are encouraged to begin preparing to submit their reports to ensure they have all the information needed to file by the deadline. Any technical questions about filing the report should be directed to DOAA (lmmhelp@audits.ga.gov or www.audits.ga.gov). All questions regarding the legal requirements about the report should be directed to your county attorney.

Annual SPLOST Reports Also Due on December 31

State law (48-8-122) requires each county and city to publish an annual special purpose local option sales tax (SPLOST) report in their local newspaper and on their website before December 31, 2015. Please remember that, in addition to the current SPLOST funds, the reporting requirements apply to all previous SPLOST projects where the county has not spent all the collected proceeds. Counties are not responsible for reporting on any city projects.

ACCG Computing County Official Salary Guide for 2016 Now Available

ACCG's "Computing County Official Salary Guide for 2016" is now available. The guide assists county staff in calculating state mandated salaries for several county elected and appointed officials. It includes the 1 percent cost of living increase adopted by the General Assembly. It has been reviewed and approved by the Georgia Sheriff's Association, the Constitutional Officers Association of Georgia, and the Magistrate Judges Council.

The guide also explains newly enacted limitations to county paid supplements for superior court judges, district attorneys, circuit public defenders, and state paid employees in the district attorney's and circuit public defender's offices.

Time to Set Qualifying Fees for 2016 Election

The county governing authority is required to set and publish the qualifying fees for county offices (i.e., commissioners, sheriffs, tax commissioners, superior court clerks, magistrates, probate judges, state court judges, solicitors general, coroners, and surveyors) by **February 1, 2016**. Commissioners should adopt a resolution setting the qualifying fee for each office.

Update on DOR's BOTSS Program

The Georgia Department of Revenue (DOR) continues to operate the Business Occupational Tax Submittal System (BOTSS) Program, which allows Georgia counties and municipalities the option to share information with the Department to help identify businesses that are unregistered for sales & use tax. By providing business occupational license information to the DOR, the DOR can determine which businesses should be registered.

Once this information is given to the DOR, they determine whether the business is already registered for sales & use tax. If not, they review the North American Industry Classification System (NAICS) code to see if registration is required for that type of business. These processes help identify which businesses to investigate further.

In order to participate, the county or municipality must pass a resolution authorizing participation and email a copy of the resolution to sharon.doughty@dor.ga.gov. A username/password will be assigned by the DOR upon receipt. Information may be submitted in batches or individually through the Georgia Tax Center at www.gtc.ga.gov. The DOR must have the business legal & trade name (DBA), mailing and location address, sales and use tax number, and the NAICS code number in order to process the submission. In addition, information such as the federal employer identification number (FEIN), ownership type (e.g., S-Corporation, Sole Proprietorship), owner name and social security number, and the business start date may also be requested.

Counties are encouraged to take advantage of this program, which helps ensure compliance with sales & use tax registration requirements, which leads to additional tax revenues for local governments as well as the State. Currently, over 70 counties and municipalities have participated in the program.

Federal FAST Act is Signed into Law

The president recently signed the "Fixing America's Surface Transportation (FAST) Act" into law. The FAST Act is the longest surface transportation funding bill passed by Congress in more than a decade. It will provide \$305 billion in funding through FY2020.

The FAST Act will improve the nation's roads, bridges, transit systems, and rail transportation network. It also streamlines the environmental review and permitting process to expedite project completion, prioritizes spending on nationally significant freight corridors, and provides long-term certainty and more flexibility for states and local governments while also maintaining a strong commitment to safety. Benefits of the FAST Act for Georgians include over \$6.8 billion in funding allocated to the state through FY2020. That allocation is \$607 million above the funding levels set by the MAP 21 Act in 2012.
